Gregers is the Chairman of the "Green Buildings and Sustainable Communities" committee under the EU-Malaysian Chambers of Commerce and Industries (EUMCCI) and regularly contributes to green building articles and frequently lectures at universities. He has a keen interest to pursue innovative and integrated design solutions bridging the gap between architects and engineers.
